- Demonstrate English language proficiency
- Applicants who have completed their high school or secondary education in English medium are exempt from submitting standardized test scores (e.g., IELTS or TOEFL)
- Others may either submit valid English proficiency scores or opt to take the EIU-Paris in-house English proficiency test during the application process
- Possess basic digital literacy and access to a reliable internet connection
- Demonstrate strong motivation, self-discipline, and readiness for online learning



Mature Entry Route (case-by-case basis):

Experienced professionals without formal high school qualifications may be considered if they can demonstrate at least 3 years in a verified middle to senior management role within a business or organizational context.

Note: Applicants with prior post-secondary education or relevant work experience may be eligible for credit transfer or accelerated progression within the programme.

Programme Overview:

The final Action Research Project (minimum 5,000 words) enables students to specialize in an area of interest—for example, an MBA student researching digital business trends may graduate with an MBA in Digital Transformation, while another focusing on people strategy may earn an MBA in Leadership.
